#### DEPARTURE SENTENCES

## AGGRAVATING FACTORS: OAR 213-008-0002(1)(b)

1) Deliberate cruelty; 2) Vulnerable victim; 3) Threat of actual violence 4) Persistent involvement unrelated to current crime: 5) Use of a weapon 6) Violation of public trust or professional responsibility; 7) Multiple victims or incidents - unrelated to current crime; 8) Organized criminal operation; 9) Permanent injury to the victim; 10) Harm or loss significantly greater than typical; 11) Motivated entirely or in part by the race, color, national origin or sexual orientation of the victim.

### MITIGATING FACTORS: OAR 213-008-0002(1)(a)

1) Victim was an aggressor or participant in criminal conduct; 2) Defendant acted under duress or compulsion; 3) Diminished mental capacity (excluding drugs or alcohol); 4) Offense principally accomplished by another and defendant exhibited extreme caution or concern for victim; 5) Offender played a minor or passive role; 6) Offender cooperated with the state; 7) Degree of harm or loss attributed to the current crime of conviction was significantly less than typical; 8) Offender conviction free for a significant period of time; 9) Same as optional probation criteria.

## OPTIONAL PROBATION OAR 213-005-0006

If offense is classified in GB 8 G,H or I the court may impose optional probation upon making following specific findings on the record: 1) An appropriate treatment program is likely to be more effective than presumptive prison term in reducing the risk of offender recidivism; 2) The recommended treatment program is available and the offender can be admitted to it within a reasonable period of time; and 3) The probationary sentence will serve community safety interests by promoting offender reformation.

This option is not available if: 1) A firearm was used in the commission of the offense; or 2) if the offender was under supervision for a felony, or juvenile felony adjudication; or 3) for UMCS/meth (substantial quantity).

## **DETERMINATE SENTENCES ORS 137.635-7**

If a person is convicted of Murder, Manslaughter I, Assault I, Kidnapping I, Rape I, Sodomy I, Unlawful Sexual Penetration I, Burglary I, Arson I, or Robbery I, and has been convicted of any one of the above named crimes, then the defendant must receive a determinate sentence to the Department of Corrections, the length of which the court must set, and the defendant is not eligible for probation. Gridblock numbers for CS7 Crimes (Burglary I) are as follows: 7l (11-12), 7H (12-13), 7G (13-14), 7F (14-15).

(Note: Judge must indicate that sentence is a 137.635 sentence in the sentence order)

Rape I/Sodomy I /Sexual Penetration I: CS10 if any of the following: 1) offender used or threatened use of weapon; 2) offender caused/threatened serious physical injury; 3) victim under 12; 4) victim incapable of consent because of mental defect, incapacitation, physical helplessness; otherwise CS 9.
